

E-Packing Slip:

Streamlining Inventory Data Exchange from IRT Systems to Vestigo®

What is the E-Packing Slip?

The E-Packing Slip is a downloadable file from the IRT that provides inventory details of a shipment, facilitating electronic communication between the sponsor and the site.

How Does the Process Work?

Rather than manually entering shipment information into Vestigo®, the E-Packing Slip is uploaded to automatically populate shipment and IP details into Vestigo®.

How the Process Works



Physical Shipment

- Receive and unpack shipment.
- Match Physical contents to the paper packing slip.



IRT

- Log in to the IRT system to register and acknowledge shipment.
- Download new universal packing slip file with IP inventory details.



Vestigo®

- Import file via new tool.
- Shipment/IP inventory details automatically populate.
- Align, view, and confirm detailed shipment data.

Who will use the E-Packing Slip?

A clinical trial site receiving an IP shipment on a participating protocol.

What are the benefits of the E-Packing Slip?

- Aligns shipment contents and IP details between the IRT and Vestigo[®].
- Reduces time and transcription errors by eliminating manual data entry during the receive process.
- Provides an industry-wide data specification supporting standardization, accuracy, efficiency, and improved site satisfaction.



Everyone can play a role in supporting the standardization of the E-Packing Slip on all protocols.

For Clinical Trial Sites:
